A nonprofit or community-based organization focusing a portion of the agency's programming on domestic violence prevention and/or services and supports the mission, vision and values of the Rhode Island Coalition Against Domestic Violence (RICADV).

About the RICADV:

Mission:

The purpose of the RICADV is to eliminate domestic violence in Rhode Island. Our mission is to support and enhance the work of our member agencies and to provide leadership on the issue of domestic violence.

Vision:

We envision a society where domestic violence is not tolerated because communities are enlightened and responsive to the needs of victims and their children.

How We Do Our Work:

The RICADV affirms that all people have the right to live their lives free from fear and violence. To this end, we are working to disrupt the systems of oppression that unjustly impact people of color, Jews, Muslims, LGBTQ people, and other historically oppressed communities. Aspiring to be an anti-oppression organization is not a separate part of our work but the lens that informs how we do our work. It is at the heart of moving our mission forward.

ADVOCACY AND POLICY

- Participate in the RICADV policy agenda conversations to improve systems and public policy for survivors of domestic violence and their families
- Attend our Legislative Advocacy Workshop (LAW 101)

- Receive alerts and updates on state and national legislative and policy issues affecting domestic violence survivors

REQUIREMENTS FOR AFFILIATE MEMBER AGENCIES



- A portion of the agency's programming must be focused on domestic violence prevention and/or services.
- Affiliate member agencies are required to have been in existence for a full year since the date the agency filed for a 501c3 status and must demonstrate fiscal viability.
- Applicants must demonstrate the agency is meeting an unmet community need, without duplicating existing services for victims of domestic violence.
- Applicants must demonstrate how their organization's values align with the vision/values of the RICADV.
- Affiliate member agency annual dues will be set annually by the RICADV's Board of Directors, on a sliding scale based on the size of the organization and the amount of funding the RICADV subcontracts to the agency. Current affiliate member agency dues range from \$250 to \$2,500 based on this criteria.
- Affiliate member agencies must have workplace policies about domestic violence as part of the organization's employee handbook.
- Affiliate member agencies may be subject to an annual monitoring visit from the RICADV.
- Applicants may submit letters of support.
- Failure to meet any of the above requirements may subject the agency to revocation of their membership by the board of directors. The decision of the board is final.

APPLICATION PROCESS

- Upon receipt of the request for information, the RICADV will send the interested party information about membership and an application form.
- The applicant should complete the application form and send it electronically by fax at 401-467-9943 or by emailing ricadv@ricadv.org, or by mail to 641 Bald Hill Rd, Suite 100 Warwick, R.I. 02886, Attn: Community Engagement Specialist, with the required attachments.
- The RICADV Membership Committee of the Board of Directors will review the application package and an in-person interview will be scheduled with representatives from the applicant within 60 days of receiving the completed material.
- The membership committee will present its recommendation to the RICADV Board of Directors for approval within 60 days of meeting the applicant.
- The decision of the board of directors is final.
- Applicants are encouraged to submit a new application after two years if the application is denied.
